Grants of Probate/ Letters of Administration

Obtaining Grant of Probate – <u>non-taxable estate</u> - based on information provided by you - In the region of £1,500 plus VAT - £2,000 plus VAT – fees may be higher depending on the complexity i.e. if we have to complete forms for non-proving executors, deeds of variation or complete forms for claiming inheritance tax allowances.

Obtaining Grant of Probate – <u>taxable estate</u> – based on information provided by you In the region of £2,500 plus VAT- £3,000 plus VAT - fees may be higher depending on the complexity i.e. if we have to complete forms for non-proving executors, deeds of variation or complete forms for claiming inheritance tax allowances.

Property and Financial Affairs LPA - (LP1F – Financial Decisions)

This gives a person (or persons) nominated by you the right to buy and sell property on your behalf; operate bank and building society accounts; deal with investments; pay bills; buy items for you and on your behalf; deal with your tax affairs and Department of Works & Pensions benefits. You can give as wide a power as you wish.

Personal Welfare LPA – (LP1H Health and Care Decisions)

This covers issues such as medical treatment (including making decisions on life sustaining treatment), housing, day to day care, assessment for community care services, and personal correspondence etc. Again, you can give as wide a power as you wish.

Deputyship Order

You can apply to become someone's deputy if they 'lack mental capacity' - this means they can't make a decision for themselves at the time it needs to be made. They may still be able to make decisions for themselves at certain times. People may lack mental capacity because, for example:

- they've had a serious brain injury or illness
- they have dementia
- they have severe learning disabilities

As a deputy, you'll be authorised by the Court of Protection to make decisions on their behalf.
